指标说明

1. 本年鉴约定 :成交金额、成交数量以交易的买方或卖方单边计算 ,交易金额、交易数量以交易的买方和卖方双边计算。所以 ,总交易金额等于总成交金额的两倍。

2. 单位 :除非特别说明 ,本年鉴中金额的单位为百万元人民币 ,B 股换算为人民币计算 ,数量的单位为百万股 (张、份) ,国债期货单位为口 ,国债回购单位为手。

3. 统计范围 :在本所上市交易或联网交易的各类证券 ,包括股票(A 股、B 股) ,基金 ,权证(认股权证、A1 权、A2 权、B 权) ,企业债券(含可转换债券) ,国债(现货、回购、期货)。

4. 统计内容 :包括本所上市的各类证券的交易状况和参与者的交易状况 ,会员情况及交易状况等。

5. 统计时期 :1998 年 1 月 1 日至 1998 年 12 月 31 日。为便于对比 ,增加 1991 年至 1997 年的部分相关数据。

6. 数据类型 :证券数目及会员数目、股本、市值、市盈率、股价、指数等为月底或年底的时点数字 ,不具时可加性 ;交易金额、交易数量等为全年或某月的时期数字 ,具有时可加性 ,由相应时期内各交易日的实际数字累加而成。

7. 零股交易 :零股交易已计入当月和当年的交易统计数字中 ,但总交易日数不包括零股交易日数。

8. 舍入误差 :本年鉴数字采用截尾方式计算 ,个别数字采用四舍五入方式计算。由于舍入误差 ,分类数字之和未必等于总额数字。

9. 上市公司数 :其股票在本所上市的公司数目。

10. 上市证券数目 :包括在本所直接挂牌或联网挂牌的各类证券数目。

11. 会员数 :申请成为本所会员的数目。

12. 席位数 :包括本所会员申请的席位及其他非会员申请的特别席位 ,如国债专席 ,B 股境外券商特别席位 ,联网中心特别席位。

13. 发行股本 :指上市公司发行在外的 A 股和 B 股股本 ,不含 H 股股本。

14. 上市面额 指除股票外的其它证券在本所直接或联网挂牌的面额数量。

19. 交易日数 :分 A 股交易日数 ,B 股交易日数 ,不含零股交易日数。

24. 成交笔数 :由交易系统完成配对交易的记录数。

25. 分红派息 :指 1998 年内上市公司根据分红派息方案派发的红股和股息。

26. 配股 :1998 年内上市公司的配股活动。配股集资金额 = 配股价 \times 实际配股数。

27. 内部职工股 :1998 年度内部职工股的上市情况。

28. 停牌情况 :1998 年内发生的证券停牌及原因。

29. 集资金额 :包括上市公司发行集资和配股集资。

30. 分类统计 :将上市公司分为工业、商业、金融、地产、公用事业和综合企业六类,分别进行统计。

Notes to Statistics Indicators

1. *Specification of the Fact Book* :Transaction turnover and volume are calculated on an unilateral basis , while trading turnover and volume are counted on a bilateral basis. Accordingly , total trading turnover is twice as much.

2. *Unit* :Except for special notes , calculation unit of turnover shall be RMB million. B share turnover is calculated after converting Hong Kong dollar into Renminbi. Calculation unit of trading volume of equities and funds is one million , while that of TB futures and TB repurchase is one contract and one board lot , respectively.

3. *Products Included* :All the securities listed on the Exchange or traded on the Exchange via computer link. These securities include equities (Class A & B shares) , funds , warrants , rights (A- share rights , A1 rights , A2 rights and B- share rights) , corporate bonds (including convertible bond) and treasuries (treasuries cash , repurchase and futures) .

4. *Contents* :Transaction of all the securities listed on the Exchange , participation of investors , information and performance of member brokers.

5. *Covered Period* : January 1 — December 31 , 1998. Related information from 1991 to 1997 is added for reference.

6. *Statistics Classification* :Number of securities , members , stock capital , market value , P/E ratio , stock prices and stock price indices are the month-end or year-end figures , not timeaddable. Traded value and volume are the year or month figures and are cumulative of the virtual figures in the trading days in the related time period.

7. *Trading of Odd Lot Shares* :Odd lot shares transaction is included in the trading statistics of the month or year , but the number of their trading days are excluded in the total number of trading days.

8. *Rounding-off Error* :Calculation is conducted on an end cut or rounding off basis. Due to the rounding off error , the figures of all the indicators added may not equal to the total amount.

9. *Number of Listed Companies* :The figure of the number of listed companies refers to the total number of companies whose stocks are listed on the Exchange.

10. *Number of Listed Securities* :The figure of the number of listed securities refers to the total number of securities listed on the Exchange or traded on the Exchange via computer link.

11. *Number of Members* :The figure of the number of members refers to the total number of member brokers of the Exchange.

12. *Seats Number* :The figure of the number of seats refers to the total number of trading seats include those of the members and special trading seats of non-member traders such as TB seats , B share seats and seats of securities centres linked to the Exchange.

13. *Issued Capital Stock* : outstanding capital stock of A and B shares , excluding that of H shares.

Total capital stock = \sum capital stock of A shares + \sum capital stock of B shares

14. *Listed Par Value* : gross par value of securities other than equities listed on the Exchange or traded on the Exchange via computer link.

Total listed par value = \sum par value of corporate bonds + \sum number of fund units + \sum number of warrants and rights

15. *Total Market Value* : Market value of equities = \sum total issued capital stock \times closing price
 Market value of other securities = \sum total listed par value \times closing price/par value of each

16. *Average P/E Ratio* : average P/E ratio of equities only.

$$\begin{aligned} \text{Average P/E ratio} &= \frac{\sum \text{total market value of equities}}{\sum \text{gross profit earnings of equities}} \\ &= \frac{\sum (\text{closing prices} \times \text{total capital stock})}{\sum (\text{PSE} \times \text{total capital stock})} \end{aligned}$$

17. *Change of Securities Prices*

$$= \left(\frac{\text{closing price of the month or year}}{\text{closing price of the previous month or year} \times \text{adjusted factors}} - 1 \right) \times 100\%$$

$$\text{Adjusted factors} = \frac{\text{ex-right price}}{\text{closing price on the registration date of share right}}$$

Ex-right price =

$$\frac{\text{closing price on the registration date of share right} - \text{dividend} + \text{share placing price} \times \text{share placing ratio}}{1 + \text{bonus ratio} \times \text{share placing ratio}}$$

18. *Stock Price Indices* : composite stock price indices and component stock price indices. Closing indices are the month-end or year-end indices. The high and low refer to the high and low of closing indices.

19. *Trading Days* : Trading days of both A and B shares except for those of odd lot shares. Total number of trading days = Whichever market (A shares or B shares) has more number of trading days.

20. *Total Transaction Turnover* : turnover of equities + of funds + of corporate bonds + of treasuries.

Cumulative transaction turnover of the year = \sum daily transaction turnover of the year including that of the odd lot shares






历年上市公司数与上市股票数




历年上市公司总股本和流通股本




历年上市公司总市值和流通市值
